EARLY CHILDHOOD SCIENCE EDUCATION IS IMPORTANT, BUT MOST PUBLIC SCHOOLS FACE OBSTACLES TO INCLUDING IT IN THEIR CURRICULUM. MANY PUBLIC SCHOOL TEACHERS DO NOT HAVE THE TIME, SCIENCE BACKGROUND, INSTRUCTIONAL MATERIALS, OR FACILITIES TO TEACH SCIENCE, YET STUDIES SHOW THAT EARLY EXPOSURE OF CHILDREN TO STEM SUBJECTS IS CRITICAL TO SPARKING A LIFE-LONG INTEREST.
